**Sewer** – Leakage report due, Council Member Ward will call DEQ and investigate contents of report. Wayne Lloyd will assist. Manhole by Kelly Payne’s’, Mark Wilsons’ and T.J. Nelsons’ needs to be fixed.

**City Hall** –May Days ready to go. Portable bathroom will be needed by July 1. Discussion on adding steps on front of Recreation Hall, RFQ needed, specs needed.

**Planning and Zoning** - New proposed Development Permit discussed. Lengthy discussion on the mission and direction of the P & Z. It was decided to have a joint meeting to get all members of the Council and the P & Z in agreement.
