SUMMARY OF BLOOMINGTON IDAHO ORDINANCE NO. 2024-2, ANNEXING NELSON PROPERTY INTO BLOOMINGTON CITY LIMITS.

TITLE: NELSON PROPERTY ANNEXATION.

AN ORDINANCE OF THE CITY OF BLOOMINGTON, IDAHO, SETTING FORTH A FINDING THAT ERIC AND JENNIFER NELSONOWN REAL PROPERTY GENERALLY LOCATED SOUTH AND EAST OF 5TH STREET NORTH, BLOOMINGTON, BEAR LAKE COUNTY, IDAHO; AND FINDING THE PROPERTY IS CONTIGUOUS AND ADJACENT TO THE CITY LIMITS OF BLOOMINGTON: THE ORDINANCE PROVIDES THE FULL LEGAL DESCRIPTION OF THE PROPERTY: THE CITY HAS FOUND THAT ANNEXATION OF NELSON'S PROPERTY INTO THE CITY LIMITS OF BLOOMINGTON FALLS UNDER CATEGORY A OF IDAHO CODE 50-222; THE CITY FINDS THAT SAID REQUEST FOR ANNEXATION OF THE NELSON PROPERTY IS PROPER AND THAT SAID NELSON PROPERTYSHALL BE ANNEXED INTO THE CITY OF BLOOMINGTON, BEAR LAKE COUNTY, IDAHO; THE ORDINANCE DIRECTS THE CITY ENGINEER TO UPDATE MAPS AND BOUNDARY LINES ACCORDINGLY; THE ORDINANCE REPEALS OR ANNULS ALL ORDINANCES, RESOLUTIONS, DESCRIPTIONS OR PARTS THEREOF IN CONFLICT HEREWITH: AND DIRECTS THE CLERK OF THE CITY OF BLOOMINGTON TO FILE A CERTIFIED COPY OF THE ORDINANCE AND MAP OF THE AREAS TO BE ANNEXED WITH THE BEAR LAKE COUNTY RECORDER AND THE STATE TAX COMMISSION FOR THE STATE OF IDAHO, PURSUANT TO IDAHO CODE SECTION 50-223 AND SECTION 63-2215; THE WAIVES THE THREE READING RULE AND ESTABLISHES AN EFFECTIVE DATE OF THIS ORDINANCE.
